**BUDGET MESSAGE  
FY 15**

The County's assessed valuation went from \$1,168,956,285 in FY 14 to \$1,407,977,674.00, a net increase of \$239,021,389.

County employees, with the exception of Elected Officials, were given up to a 3% salary adjustment and a .5% increase to the County's Contribution to their retirement that was in line with the salary adjustments at the local level with the city, towns, hospital and state. The premium for the County's Health Insurance had a small increase. On average, the increased cost to the employee is \$12.75/month and \$37/per employee per month to the County. The County is continuing the Wyoming Retirement System Pension Plan and the full premiums are paid by the County for all qualifying employees.

Other personnel changes: the Sheriff's Office was allocated an additional Weights & Measures position, along with a vehicle and equipment; Jail, 1 additional employee for transport of inmates; Road & Bridge 2 additional operators and a ½ time secretarial position; County Attorney's Office, decrease of 1 employee.

Several road and bridge projects were addressed with the FY 15 budget. Funding for these projects will come from a variety of sources:

*Note:* The County has around 640 miles of county roads, with most being unpaved. The Commission is addressing many road, bridge, and culvert projects due to the heavy use by various industries. For the most part, the County Road & Bridge Department addresses other road projects through their operating budget. The projects listed above, along with \$4,041,166 in the R&B operating budget that includes \$300,000 for snow fence; \$75,000 for gravel, and \$900,000 for contracts, reflects the County's commitment to maintain and repair its roads.

The County will use the Direct Distribution "Over-the-Cap" funds for the following specific road project: Irvine Road, \$426,493 towards this \$645,000 project.

The Sheriff's Office received authorization for three new patrol vehicles. The Road and Bridge Department received authorization to continue leasing two blades, purchase one pickup, two blades, four v-plows, Jaw Crusher for gravel, portable patching machine, gooseneck trailer, and a live floor trailer for a total of \$1,380,891.

The County Treasurer's Office received an additional \$70,000 in one-time funding for digital archiving of the tax rolls from 1889 through 2005. The Assessor received \$372,000 for a GIS project with Pictometry with an estimated reimbursement of \$100,000+ to the General Fund from outside, participating partners.

The County was able to put \$3,918,000 in the Operating Reserve; \$3,995,770 in the Building/Maintenance Reserve; and \$350,000 in the Equipment Reserve. The County funded "Aid to Others" at a \$594,500 up 36% from the previous FY.

Overall, the County is in very good financial condition going into the current fiscal year.
