- **B.** GFD's retention and recruiting program is going well. They have a potential for 5-6 new firefighters in Rolling Hills and 5-6 new firefighters in Glenrock.
- **C.** Motorola is installing servers today at the Dispatch Center. Agency participation is expected to happen in August.
  - **D.** Work and planning are ongoing with the training center.
  - **E.** DFD is changing its by-laws.
  - **F.** RFD's annual meeting will be June 28, 2019.

#### VI. New Business

- **A.** The Board reviewed a letter from L. Taylor regarding overdrafts for insurance. Insurance was discussed at the July and at the August board meetings. If the County Commissioners does not forgive the overdraft, the FSA will submit a check.
- **B.** M. Nicol moved to approve an invoice for the purchase of wildland masks for DFD; T. Wills seconded. All Ayes. Motion Carried.
- **C.** An overall proposed budget was submitted to the Department of Audit Public Funds per their requirement. After the meeting with the Commissioners and the public budget meeting in July, the proposed budget will be finalized.

- **D.** T. Sherman stated that new trainees have started and will be starting at the dispatch center. She asked that callers ask for "dispatch" not "fire dispatch." The dispatchers have a screen on the radio that shows who they are talking to.
  - **E.** Any budget amendments will need to be presented at the next board meeting.
  - **F.** T. Reed stated there is no fire ban in place at this time.
  - **G.** GFD will be hosting fireworks at South Rec. DFD will be detonating fireworks at the high school.
