**WHEREAS**, on the 15<sup>th</sup> day of May, 2019 the Converse County Clerk, the budget-making authority, prepared and submitted to the Board of County Commissioners the budget for the FY 20, the fiscal year ending June 30, 2020; and

**WHEREAS**, notice of public hearing on such budget, together with the summary of said budget was published in the *Douglas Budget* July 3, 2019, a legal newspaper published in the County of Converse and of general circulation, and

**WHEREAS**, a public hearing was held on such budget at 4:00 p.m. in the Converse County Courthouse in Douglas, Wyoming on July 15, 2019 at which time all interested parties were given an opportunity to be heard; and

**WHEREAS**, following such public hearing, no alterations or revisions were made to such proposed budget,

**NOW THEREFORE BE IT RESOLVED** by the Board of Converse County Commissioners that the County budget be adopted as the official County Budget for the FY 20 ending June 30, 2020 and that the expenditures of each officer, department, or spending agency be limited to the amount herein appropriated.
